## Foreign nationals traveling to Azerbaijan required to have a COVID-19 passport

On June 09, 2021 Cabinet of Ministers of the Republic of Azerbaijan adopted a Decree on amendments to the *“Temporary Rules for Organization of Flights and Passenger Air Transportation in the Republic of Azerbaijan during the Coronavirus (COVID-19) Pandemic”* (hereinafter referred to as the *“Amendments”*).

Amendments introduced the following requirements for foreign nationals and stateless persons arriving in Azerbaijan by air transport:

- ▶ Persons over the age of 18 should have (i) **COVID-19 passport** (a document confirming full vaccination against COVID-19 or immunity to COVID-19); and (ii) Medical certificate confirming a negative COVID-19 PCR test result issued at most 72 hours before the flight;
- ▶ Passengers aged 1 to 18 years should have medical certificate confirming a negative COVID-19 PCR test result issued at most 72 hours before the flight.

As for returning Azerbaijani nationals, they shall be allowed to travel with a document confirming the negative result of the PCR test issued at most 72 hours before the flight.
